PINEWOOD GROUP ANNOUNCES CLOSING OF OFFERING OF SENIOR SECURED NOTES DUE 2027

London December 2, 2021: Pinewood Group Limited (together with its subsidiaries, the “Pinewood Group”) today announced that its wholly-owned subsidiary, Pinewood Finco plc (the “Issuer”), closed the offering (the “Offering”) of £300,000,000 aggregate principal amount of its 3½% senior secured notes due 2027 (the “Notes”).

The proceeds from the Offering will be used, along with cash on balance sheet, to: (i) fund expansion projects, including the Shepperton Expansion Project and five new stages at Pinewood West, and (ii) pay fees and expenses related to the Offering.

The Pinewood Group is the leading provider of studio and related services to the global film and television industry. Founded in 1936 and headquartered in the United Kingdom, the Pinewood Group has helped create some of the big and small screen’s most treasured productions, which have received among them 170 Oscar awards and 230 BAFTA awards.
