

## WI-FI TERMS OF USE

### 1. TERMS OF WEBSITE USE

This page (together with the documents referred to on it) details the terms of use for Pinewood's free wireless Internet access system ("Wi-Fi System") ("Wi-Fi Terms of Use") Please read these Wi-Fi Terms of Use carefully before you access the Wi-Fi System. Please note that we may update these Wi-Fi Terms of Use from time to time so please review these pages regularly. We are not responsible for the content of external sites.

BY ACCESSING THE WI-FI SYSTEM YOU ACCEPT THESE WI-FI TERMS OF USE AND AGREE TO ABIDE BY THEM. IF YOU DO NOT AGREE TO THESE WI-FI TERMS OF USE PLEASE REFRAIN FROM USING THE WI-FI SYSTEM.

### 2. INFORMATION ABOUT US

The Wi-Fi System is operated by Pinewood Studios Group ("**we**"). Any reference in these Wi-Fi Terms of Use to "**you**" or "**your**" means you as a user of the Wi-Fi System.

### 3. ACCESSING THE WI-FI SYSTEM

In consideration of you accepting these terms and conditions, we agree to provide you with the service free of charge and this gives you the ability to access the internet and send and receive data through our wireless broadband network and through the internet using wireless technology from a designated site with access points for the service (a hotspot). Access to the Wi-Fi System is permitted on a temporary basis and we reserve the right to withdraw or amend the service we provide without notice (see below). We will not be liable if for any reason the Wi-Fi System is unavailable at any time or for any period. From time to time, we may restrict access to some parts of the Wi-Fi System.

The service we provide to you under these terms is for business and consumer use. The service does not include connection from our network to any customer network or any services when you are connected to the internet. The service may be impaired by geographic, atmospheric or other conditions or circumstances beyond our control.

When using the Wi-Fi System, you must comply with the provisions of these Wi-Fi Terms of Use. You accept that we have no control over the information transmitted via the service and that we do not examine the use to which you put the service or the nature of the information you send or receive. We have no obligation to compensate you for such information and such use.

We cannot guarantee access to any hotspot for you to use the service, or guarantee that service will continue to be available from any hotspot.

You are responsible for making sure any equipment you use to access the service is: (a) suitable for use with the service; (b) adequately protected against external threats

including but not limited to viruses, worms, trojans; and (c) meets any instructions for its use.

#### **4. MISUSE AND INTELLECTUAL PROPERTY RIGHTS**

We may remove, block, filter or restrict by any other means any site or materials that, in our sole discretion, we deem appropriate.

Due to the nature of the service, you accept that we cannot guarantee the security of the service against unlawful access or use.
