PART 2 - Hazard Assessment

Pinewood Studios is an expansive and busy site covering many acres of land and encompassing a wide variety of activities. The Studios has evolved over a period of around 80 years on land that originally formed the estates of country houses. This has led to a mix of old and new buildings, workshops and stages many of which are quite tightly packed together. Roadways inbetween vary in width and corners can be blind. Productions hiring our facilities take over stages and backlots. When they do so they assume control of the activities being carried out in these spaces for the duration of the contract we have signed with them.

General Comments

Although those attending the Futures Festival will be escorted at all times by their own parent/ legal guardian or teacher as well as Pinewood designated employees, a variety of risks exist on site including: Vehicles & pedestrians, slips & trips, proximity to construction sites, & fire (given the fire load within our stages).

Pinewood Futures Festival is to take place on 28/02/2025 & 01/03/2025 with the aim to inspire and educate young people (14-22 year olds). A number of buildings and stages will be visited throughout the two days with an approximate attendance of 4000 people divided into 6 entry sessions of approximately 700 people each. Each session group will be sub-dived into groups of 30 people who will be accompanied by Pinewood Group employees at all times.
